About the conference

The Populism and Civic Engagement (PaCE) conference was an event gathering project partners, academics, policy actors, journalists and civil society representatives to present and summarise findings on populism in Europe. It took place on 15-18 November 2021. Uncertainties and constraints caused by the COVID-19 pandemics required us to redesign the conference format against the initial plan outlined in the project proposal. Due to travelling restrictions enforced by public and partner institutions, and the number of participants allowed for in-person events, it became unfeasible to organise a two-day conference in line with the target number of participants, including youth representatives. Therefore, we decided to organise the conference in a hybrid manner, splitting events into three days:

1st day - in-person roundtables (7) with invited speakers and guests in Brussels (Residence Palace)

2nd and 3rd day - online webinars (6) hosted by the project partners

This solution enabled the participation of partners and guests who could not take part in the conference physically. The in-person part of the conference was focused on inviting local, Brussels-based actors who were not affected by the travelling restrictions.

It was impossible to gather youth participants from across Europe to participate in the event for the reasons explained above. Instead, we decided to address the involvement of young people in the debate on populism by developing an educational scenario for schools and educational organisations that they could run in their environments. A detailed approach is presented in the corresponding deliverable 5.9.







Conference Program

The Populism and Civic Engagement (PaCE) conference summarises research findings on populism in Europe, carried out within the Horizon 2020 research and innovation programme.

Across Europe, there is a rise of political movements that claim to challenge liberal elites and speak for the 'ordinary person' – movements that can be loosely categorised as 'populist'. Many of these movements have undesirable tendencies. PaCE project aims to combat the negative tendencies of populist movements, build upon the lessons of positive examples, and hence play a part in constructing a firmer democratic and institutional foundation for the citizens of Europe.

In this event, we aim to present findings from our research carried out by the PaCE consortium partner institutions and, together with participants and stakeholders, develop the approaches to connect research with policy-making.

Thematic tracks of the conference:

- 1. Understanding populism
- 2. New tools for understanding populism
- 3. Policy actors' response to populism

For the conference as a whole, there were 77 registrations. There were 57 participants registered for the in-person conference. They gathered for the expert sessions on the day. The covid-19 situation resulted in fewer participants in in-person expert sessions, some due to cancellations. Overall, we are glad to gather such a total of people within the pandemic conditions.

Participants came from thirty different countries, with the highest numbers of registrations from Belgium (38 registered), the UK (13) and Bulgaria (12). The online seminars offered the opportunity for people from all over the world to join the sessions.
